**NOTICE PURSUANT TO SECTION 708A(5)(E) OF THE CORPORATIONS ACT 2001**

(“**European Metals**” or “**the Company**”) is pleased to advise that it has issued 6,517,142 fully paid ordinary shares (“**Placement**”) at \$0.615 per share as announced on 30 November 2017.
